## **Police Chief's Report**

The budget is running to its projection.

## **Road Commissioner Report**

The National Grid project on Upper Drive and Locust Lane is complete and will be paved by Action Blacktop. Weather permitting, the paving should begin the end of this month or early September. National Grid will begin the project on Taylor Road next week.

# RESOLUTION AUTHORIZING A NEW CERTIFICATE OF DEPOSIT WITH FIRST NATIONAL BANK

**WHEREAS**, the New York State Village Law authorizes incorporated villages to invest and re-invest municipal funds; and

**WHEREAS**, the Village of Huntington Bay maintains accounts with First National Bank located at 253 New York Avenue, Huntington, NY 11743 and

**WHEREAS**, the Board of Trustees is vested with authority to manage finances and investments on the Village's behalf; and

**WHEREAS**, the Board of Trustees finds that it shall be in the best interests of the Village to invest Village funds in the form of certificates of deposit with First National Bank; and

WHEREAS, the proposed action is a Type II Action (6 NYCRR 617.5 [c][26]);

**NOW, THEREFORE, IT IS HEREBY RESOLVED**, by the Village of Huntington Bay Board of Trustees, as follows:

- 1) The Village is authorized to invest Village funds in the form of a new certificate or certificates of deposit with the First National Bank, Huntington branch; and
- 2) The Mayor and Village Clerk are hereby authorized and directed to complete and sign such forms and other documents required to open and manage the certificate(s) of deposit through their maturity dates.

Upon motion by Trustee Mark Dara, seconded by Trustee Barbara Beuerlein, the Board of Trustees adopted the foregoing resolution at a duly noticed public meeting held on August 14, 2023, voting as follows:
