### Village of Huntington Bay Minutes Board of Trustees July 9, 2024

The meeting was held at The American Legion Hall, 1 Mill Dam Road, Huntington, NY 11743.

Mayor Dara called the organizational meeting to order at 7:05 PM.

Town Supervisor Ed Smyth, alongside Councilwoman Brooke Lupinacci and Highway Superintendent Andre Sorrentino, swore in our new Mayor Mark Dara and Trustees Elizabeth Richter, Luan Doan, and Kenneth Anna. Trustee Richter's and Trustee Doan's positions are for two-year terms. Trustee Anna was appointed to complete the remaining year of the open Trustee position.

Mayor Dara presented the list of 2024-2025 Huntington Bay Appointments. A motion was made by Barbara Beuerlein to approve the appointments, it was seconded by Elizabeth Richter and unanimously approved 5-0.

Mayor Dara expressed his sincere gratitude to the residents for their votes and support. He conveyed his eagerness to collaborate with the community and work together towards future goals.

#### **Public Hearings:**

#### Richard Kaehler, 15 Heckscher Drive, Huntington Bay, NY 11743

Richard Kaehler, homeowner, presented the application to the Board to construct a 2nd floor addition and alterations to an existing two-story, single-family dwelling. After discussion, the Board imposed a \$5,000 road bond on the property. A motion was made by Barbara Beuerlein to approve the application. It was seconded by Elizabeth Richter and unanimously approved 5-0. A transcript was taken by Christa Flash. The hearing was closed at 7:19PM.

#### Ronald Zimmer, 4 Castle Harbor Road, Huntington Bay, NY 11743

Lenny Horchos, AIA, presented the application to the Board to construct an inground swimming pool and patios. After discussion, the Board imposed a \$5,000 road bond on the property. A motion was

made by Barbara Beuerlein to approve the application. It was seconded by Luan Doan and unanimously approved 5-0. A transcript was taken by Christa Flash. The hearing was closed at 7:28PM.

#### William and Geraldine Baum, 8 Bay Crest, Huntington Bay, NY 11743

Michael Wallin, AIA, presented the application to the Board to construct a new family dwelling. After discussion, the Board imposed a \$50,000 road bond on the property. A motion was made by Kenneth Anna to approve the application. It was seconded by Barbara Beuerlein and unanimously approved 5-0. A transcript was taken by Christa Flash. The hearing was closed at 8:05PM.

#### **Police Chief's Report**

Chief Jack delivered the Police report to the Board. There were 27 summonses, and 83 incident reports filed within the past month.

The police department has received a Law Enforcement Technology grant from the Governor's office in the amount of \$113,100. The funds will be used for acquiring new radar guns, upgrading computer systems, purchasing a new server, and equipping police cars with updated computer equipment.

#### Mayor's Report

The Mayor announced that changes to the zoning code are forthcoming. He indicated that while it will take a couple of years to alleviate the current fiscal stress, efforts will be made to improve the situation. Additionally, the Mayor clarified that moving forward, only the Village Administrator will have authorization to use the credit card.

The Mayor announced that the Village will celebrate its 100-year anniversary with an old-fashioned BBQ at Village Hall in September. The event will be funded entirely by donations. The Halesite Fire Department will participate in the celebration, marking the 100th anniversary of the Fox Ahern Fire Engine. Further details will be provided to residents as the event approaches.

The Mayor has decided to dissolve the position of website updater, Kristen Morrow, as part of an effort to save money for the Village. This change is aimed at optimizing our resources and ensuring the best use of our funds. A motion was made by Mark Dara to approve the dissolvement of the position. It was seconded by Barbara Beuerlein and unanimously approved 5-0.

#### **Road Commissioner Report**

Mayor Dara announced the appointment of Barbara Beuerlein as the new Road Commissioner. The Mayor acknowledged the significant responsibilities associated with the position, noting that it is no easy task.

Taxes were due July 1<sup>st</sup>. We currently have 35 outstanding unpaid taxes. Delinquent letters were mailed.

#### **ELECTION**

Election ran smoothly thanks to our Election Inspectors. There were 465 residents who voted in-person and 57 ballots. Total 522 votes.

A motion was made by Mark Dara to close executive session. It was seconded by Barbara Beuerlein and unanimously approved 5-0. The Board came out of Executive Session at 9:12PM.
